

Qatar and Bahrain also have substantial growth targets, with 7.1 million and 14.1 million overnight guests, respectively. Oman projects 11.7 million visitors by 2040, emphasizing long-term sustainable growth. Focusing on enhancing its tourism infrastructure, Kuwait aims to become a competitive player in the regional market.

Hotel supply is set to expand significantly across the region, with Saudi Arabia targeting 450,000 keys and the UAE aiming for 304,000 keys by 2030. Qatar and Oman also plan significant increases, with 59,000 and 65,000 keys, respectively, while Bahrain targets 35.5 thousand keys.
